

- Served in the Obama Administration as Senior Counsel to the Assistant Attorney General for Civil Rights at the USDOJ
- Provided public testimony in front of federal and state government entities and commissions, and has advised public and private leaders and organizations on disability employment
- Successfully litigated landmark ADA cases that ensured the rights of individuals with disabilities to work in competitive and meaningful employment
- Litigation resulted in moving over 11,000 individuals out of separate, unequal, exploitive working conditions, with ripple effects impacting employment opportunities for millions of Americans with disabilities
- Author of multiple government reports and evaluations on US disability employment system
- Launched national disability consulting practice
- Helped launch a leading national anti-poverty non-profit, now 23 years old; co-founder of non-profit, tackling child & family homelessness, now 20 years old
